1) The cargo shall be sigle crop year

It is acceptable to submit bids with Crop year 2024 or 2025 in all cargo

We have to load only one crop year (2024 or 2025) with Crop year Certificate.

2) In case of Thai Origin,

It is necessary to have Certificate issued by BOT, certifiying that the rice is not contaminated with Tark Province Origin

The quality has to be 100% B

3) In case of Long Grain Rice

It is necessary to have Declaration Letter issued by Exporter, certifying that the rice was passed through color sorter.

"Milled" means that "paddy" is become as "milled rice" using a rice mill.

It is necessary to have Declaration Letter issued by Exporter, certifying that the rice was milled after July 7, 2025.

4) In case of Long Grain Rice

- 1. Regarding Long grain rice, Thai Rice Exporters should prepare and keep hygiene check list of their Processing and Packing line.
- 2. MAFF request such checking list (Check and record once a day at least);
  - a) Shifters, Color Sorters, Magnet and Conveyor work normally.
  - b) Cleanliness in the factory.
- 3. If there are any defects, importer should report it to MAFF immediately.
- 4. MAFF will instruct on checking frequency and storing method for copy later.
- 5) Container shipment quantity per ports
